Update on Accomplishments:

From January 1, 2016 through April 30, 2016, we rescued 2.85 million pounds of food from being wasted, which went to alleviate hunger of those we serve through our various recipient agencies. This has an in-kind value of \$4,913,725 and is enough food to provide 2.4 million meals. This would not be possible without the support of donors like you!!!

During that time period, our volunteers donated 7,452 hours of service to help us support the community effort to rescue food and reduce hunger.

In 27 years, we have rescued over 122 million pounds of food!!!
